**New Laws for 2007**

Jerry Lomeli, Police Investigator N/C of the Willmore Community Police Center, has taken the time to review many of the new laws that were recently enacted and has summarized a few that he thought might be of interest to us:

**There were 910 new laws enacted for 2007. Some of the new laws may affect your everyday life. I would like to share some of the new laws on the books. Many of the new laws are just additions to older laws and defining certain aspects of the law. You can look at all the new laws on the Internet:**

**PENAL CODES:**

220 (b) - (Amended). It is now more serious to commit a burglary with the intent of sexual assault. Now it shall be punished by imprisonment for life with the possibility of parole.

246.3 - (amended) - Shooting a BB gun in a grossly negligent manner, which could result in injury or death to a person, is now punished by imprisonment not exceeding one year.

290.95 (amended) - Every person required to register under §290 who applies for or accepts a position as an employee or volunteer with any person, group, or organization where the applicant would be working directly and in an accompanied setting with minor children, and the applicant's work would require him or her to touch the minor children on more than an incidental basis, shall disclose his or her status as a registrant upon application or acceptance.

626.81 (a) - added - Any person who is required to register as a sex offender who comes to any school building or school grounds without lawful business is guilty of a misdemeanor.

**VEHICLE CODES:**

2800.4 (added) - makes it more serious to evade officers during a pursuit where the suspect drives on the wrong side of the road, (in the opposite direction) can be a felony.

21712 (c) and (d) - Makes it illegal for the driver to allow a person to ride in the trunk (c) and illegal for the person to ride in the trunk (d). If you see someone attempting to get into the trunk, you can call the police. Riding in the trunk has become very dangerous.

22953 (amended) - pertains to towing away a vehicle from private property. This does not affect towing from driveways, entrances to garages, or personal property areas. It pertains to parking lots that both charges for spaces and does not charge for spaces. This is due to renegade tow companies swooping on vehicles in the manner of minutes. They must now wait at least one hour.

23123 (a) (added) - This is the new one that makes it illegal to talk on a cell phone while driving at the same time. Must have "hands free" operation by July 1, 2008.

23536 and 23538 (amended) - Now allows a mandatory ten-month (10) driving privileges suspension for first offense when BAC was measured .20% or refused test.

24400 (a)(2) (amended) - makes it mandatory to drive with two headlights during darkness AND when it is raining where your windshield wipers are continuously on, so must the headlights be on.

**New Laws . . . continued**

**HEALTH & SAFETY CODES:**

122335 (added) - Makes it illegal to tether, fasten, chain, tie or otherwise restrain a dog to a dog house, tree, fence or other stationary object. This does not prohibit an owner from tethering for a short time to allow the owner to complete some task or errand or approved training. You may want to read this. Dogs cannot just be tied up in the yard to bark.

If you have any questions or you do not have access to Internet, stop in and let up print out the code and discuss the new laws.

Another important Business and Professional Code:

22435 - Illegal to remove shopping carts from business property - Misdemeanor.
